I. WHAT IS LPR

LPR is a vehicle mounted camera and software system used in Parking Department vehicles to scan vehicle license plates for proper credentials or payment in university parking facilities. The system is activated and used by parking enforcement staff while actively patrolling parking facilities.

Although LPR cameras are focused to capture images of license plates on vehicles parked in university parking facilities, images/objects within camera's field of view may also be captured incidentally to the capture of license plate images.

II. WHAT INFORMATION MAY THE PARKING PERMIT SYSTEM COLLECT FROM YOU?

Personal Information

We may collect the following personal information from you:

For License Plate Recognition: License Plate, License Plate State, and assigned permit number.

For permit issuance: Name, UID, Employment Classification (faculty, staff, student). Make, model, color and year of vehicle, license plate number and state of plate. Phone, email, and address.

You are not required to provide the personal information requested; however, you may not be able to use some [*or all*] of the features offered by the Parking Permit System unless you provide personal information. - To verify that a vehicle in a Parking facility has a valid University parking permit
- To verify proper payment of permit for occupied space
- To ensure overall compliance with the terms of use and regulations for Parking facilities

IV. IS YOUR PERSONAL INFORMATION SHARED WITH ANY THIRD PARTIES OUTSIDE THE UNIVERSITY?

We may share your personal information outside the University as required by law, order of governmental authority, or court order to be disclosed; when we believe in good faith that disclosure is necessary to protect our rights, protect your safety or the safety of others, investigate fraud, or respond to a valid government request; or as necessary to deliver and maintain Parking facilities services. All collected license plate recognition data not associated with a citation or open appeal will be purged after 90 days. Please note that some or all of the user personal information may be required to be maintained in order for the Parking Permit System to function properly, and we may be required to retain certain information by law.
